Therefore you can manage and control refrigerant purchased, the allocation of cylinders to engineers and the usage of refrigerant by system from the office or while on the road.


Collection Note Generation


Diary Function

The labels ensure you comply with current regulations and when used in conjunction with the FGASmanager App the QR code can be scanned to automatically record refrigerant usage by system. FGASmanager is a complete website and app, developed exclusively for Beijer Ref UK and Ireland, for the comprehensive management of all your F-Gas requirements.

The free of charge website is compatible with all computers and mobile devices. It provides you with complete control of purchased refrigerant, the allocation of cylinders to engineers and refrigerant usage by system.

In addition, this powerful tool ensures that your activities comply with F-Gas regulations, including the ability to generate hazardous waste transfer notes automatically. The notes are generated with all the necessary fields populated and are ready to print within seconds.

Another built-in feature allows you to organise cylinder collections, or returns, from your computer and/or mobile device automatically generating the correct paperwork. The calendar feature highlights the dates that cylinders are due to be returned by. This helps to avoid any additional cylinder costs. It also highlights all cylinders that are nearing their legally required test dates.

FGASmanager can generate unique 'QR' (quick response) code stickers for individual systems and for individual customers. By using a mobile device it is easy to build a log of refrigerant usage/recovery in three simple steps; scan the system (QR code), scan the bottle (bar code) and enter the refrigerant type and weight. The website will then instantly link everything together.
